# <u>National Visa for Employment</u> skilled workers holding a university degree

[Section 18b Residence Act]

## **General Information**

As a skilled worker with a university degree recognized in Germany, you can be issued a residence permit to engage in skilled employment.

	×	Proof of adequate health insurance coverage
		Health insurance coverage is required at the time of entry into the Schengen area. Usually statutory health insurance coverage provided by the university or future employer only goes into effect when you take up residency and enter into employment/begin with your studies.
		If you enter before, an additional private (travel) health insurance in line with <u>EU standards</u> (covering the entire Schengen area, minimum coverage of 30,000 EUR) must be purchased for the duration of time until you begin your employment/your studies and are covered through the statutory health insurance. Please ensure that your travel health insurance does not exclude protection if a long term or permanent stay is planned.
